

### **Avoid travelling**

Both entering and leaving the territories, as well as within them, people are asked to move only for:

- working needs;
- situations of necessity;
- health reasons.

It is prohibited to all persons to move or relocate, with public or private transport, in a different municipality than they currently are in, except for proven business needs or of extreme urgency or for health reasons.

On holidays and pre-holidays, as well as on others that immediately precede or follow these days, any movement to homes other than the main one, including the second houses used for holidays, is prohibited.

It is not allowed to play games or any outdoor recreation. It is permitted to carry out individual motor activities in the vicinity of your home, provided that, however, respecting the distance of at least one meter from the other person.

Access to parks, villas, play areas and public gardens is prohibited.

### **Health and comply with quarantine**

People with symptoms of respiratory infection and fever above 37.5 degrees are strongly recommended to stay at home and to limit social contacts as much as possible, by contacting their doctor.

For people who have undergone quarantine or tested positive for the virus, it is strictly forbidden to leave their home or home.

### **Preschools, schools and universities suspended**

Educational services for children, educational activities in schools of all levels, as well as the attendance of school and higher education activities, including universities and institutions of advanced artistic, musical and choreutic training, professional courses, are suspended. masters, courses for the health professions and universities for the elderly, as well as professional courses and training activities carried out by other public bodies, including local and local authorities and private individuals.

There remains the possibility of carrying out distance learning activities, with the exception of courses for doctors in specialist training and specific training courses in general medicine, as well as the activities of trainees in the health professions.

### **Organized events, cinemas, theatres, bingo halls, discos are suspended**

All activities are suspended in the following places: cinemas, theatres, pubs, dance schools, game rooms, betting rooms and bingo halls, discos and similar places. All organized events are suspended, as well as events in a public or private place, including those of a cultural, recreational, sporting, religious and fair nature, even if held in closed places but open to the public, such as, for example, large events.

### **Museums and libraries closed**

Museums, libraries and archives, areas and archaeological parks and monumental complexes are closed.

### **ADMINISTRATION ACTIVITY**

The activities of catering services are suspended (including bars, pubs, restaurants, ice cream parlours, patisseries, pizza pizzerias, kebabs, frying shops).

The food and beverage administration establishments are located inside the railway and lake stations, as well as in the service and refuelling areas, with the exception of those located along the highways, which can only sell take-away products to be consumed outside the premises;

#### **STILL ALLOWED:**

- catering only with home delivery in compliance with hygiene and health standards for both packaging and transportation
- the activity of canteens and continuous catering on a contractual basis which guarantee the interpersonal safety distance of one meter.
- the activity of food and drink administration sites located in hospitals and airports, with the obligation to ensure in any case respect for the interpersonal distance of at least one meter.

### **Closed medium and large retail outlets in the weekends and holidays (except pharmacies, para pharmacies and grocery sales points)**

The medium and large retail outlets and exercises inside the malls are closed on holidays and pre-festive, with the exception of pharmacies, drugstores and grocery stores. In these structures, access must be allowed only to spaces dedicated to the sale of products related to authorized activities. Therefore, supermarkets in shopping malls can open on holidays and pre-holidays only for the sales areas of pharmaceutical, par pharmaceutical and food products. It must be guaranteed in any case the interpersonal distance of 1 meter, even through the modulation time of opening. Any form of gathering is prohibited.

### **Gyms, swimming pools, sports centres suspended**

the activity of gyms, sports centres, swimming pools, natatorium centres, health clubs, spas (except for the provision of benefits covered in the basic levels of care), cultural centres, community centres, recreational centres are suspended. These activities, to which the day centres are added, are also suspended in the other provinces, on the basis of the order of President Bonaccini.

### **Places of worship. Funeral ceremonies suspended**

The opening is conditional on the adoption of organizational measures such as to avoid gatherings of people, taking into account the size and characteristics of the places, and such as to guarantee visitors the possibility of respecting the distance between them of at least one meter.

Civil and religious ceremonies, including funeral ceremonies, are suspended.

### **Competitions and sporting events**

Sports events and competitions of all kinds and disciplines are suspended, in public or private places. Their performance is allowed, as well as the training sessions of professional athletes and absolute category athletes who participate in the Olympic games or national or international events, in sports facilities used behind closed doors, or outdoors without the presence of the public .

In any case, the associations and sports clubs, through their medical staff, are required to carry out the appropriate check-ups to contain the risk of spreading the COVID-19 virus among athletes, technicians, managers and all accompanying people who are participating.

### **The ski resorts are closed**

#### **Resort to leave and holidays**

In public and private employers it is recommended to promote the use by employees of annual leave periods and holidays, except as provided by the rules for the application of agile work.

### **Competitions suspended**

Public and private insolvency procedures are suspended with the exception of cases in which the assessment of candidates is carried out exclusively on curricular basis or electronically.

Competitions for health personnel, state and qualification examinations for the profession of surgeon and civil protection personnel, which must preferably take place remotely or, otherwise, guaranteeing the interpersonal safety distance of one meter.

### **Suspended leave**

Ordinary medical and technical personnel, as well as personnel whose activities are necessary to manage the activities required by crisis units set up at regional level, are suspended.

### **Meetings by video link**

In the conduct of meetings, remote liaison arrangements shall be adopted in all possible cases, with particular reference to health and social-health structures, utilities and coordination activated in the context of the COVID-19 emergency. In any case, the interpersonal safety distance of one metre must be respected.

### **Suspended driving examinations**

The driving licence examinations to be carried out in the peripheral offices of the Civil Motorization are suspended. By means of a management decision, applicants who have not been able to take the examinations due to this suspension are to be extended.
